Definitions

- **Data:** Text, metadata, structured data, graphics, audio, video, multimedia, and static images in various digital formats about vouchered biodiversity specimens.

- **Sensitive Data:** Data that the Data Publisher deems unfit for display, for example, localities of threatened or endangered species.
- **User:** Anyone who accesses or uses the Services.
