




# 2015 Community Survey-Visits to Portal & Website





### 2015 Community Survey - Grades











### 2015 Internal Survey - Communication





#### **Webinars - Comments**


#### **Affiliations of Respondents**








#### **Used Summit to Meet with Colleagues**











### Increase communication among TCNs/PENs

- Form working groups based on organism type being digitized (n = 3)
- Having monthly meetings was incredibly helpful for the TTD Project. I'd like to see bi-monthly meetings across TCNs.
- To promote and schedule more regular communication among the participants, at least through Adobe Connect, through the funding period and beyond
- One thing would be to publicize the IAC meetings more widely - only a very few participants outside of lead PI ever attend.



- No one complained about lack of networking opportunities!
- Ad Hoc and other spaces appreciated
- However...
  - Concerns about length and expense
  - Heavy on acronyms
  - Presentation format still an issue



### Increase communication among TCNs/PENs

- If you were to assign explicit TCN mentors it would spur more collaboration and communication.
- Focus on us as future workshop leaders and mentors for new TCNs. Might even come up with some kind of "buddy" system. Please remember that active participants are not always the project Pls.



#### But...

Sometimes I think too much emphasis is placed on communication among TCNs -- certainly there is a reason for this when different TCNs are working on similar collection types -- but aside from listening to presentations and attending the bimonthtly online meetings, I think iDigBio should not worry about communication among TCNs -- we all know who each other are, and can contact one another on our own as needed.



### **Increasing Awareness**

Any kind of advertising in appropriate venues; as it is, I learned several things about the resources available through iDigBio at this Summit that I don't think many of my colleagues know. Waiting for word of mouth will take a long time.



### **Increasing Awareness**

Researchers - More researchers need to know about the data. That means more presentations at national meetings. Students - Our path to students should be through instructors. Getting them involved means reaching out. It's up to the P.I.'s to communicate what they have with their colleagues in a meaningful way. Citizen scientists - In my opinion the best way to bring this resource to citizen scientists is through amateur clubs/groups. The general public - Finding clever ways to get into the news and popular press is the best way to bring these resources to the attention of the general public.



### **Increasing Awareness**


Primary stakeholders in this effort are the various institutions where the collections come from. These stakeholders are often NOT engaged at all. In my opinion, this is an area where iDigBio and TCN P.I.'s should focus. We need to demonstrate the value of the data (and as follows, the collections) to our university/institution administrators and higher-ups in order to justify continuing (or renewing efforts in) funding collection curation, management, research, accessibility, etc.



- 78% likely to have increased communication with other TCNs
- 66% likely to begin new collaboration
- 41% start or join a Working Group
